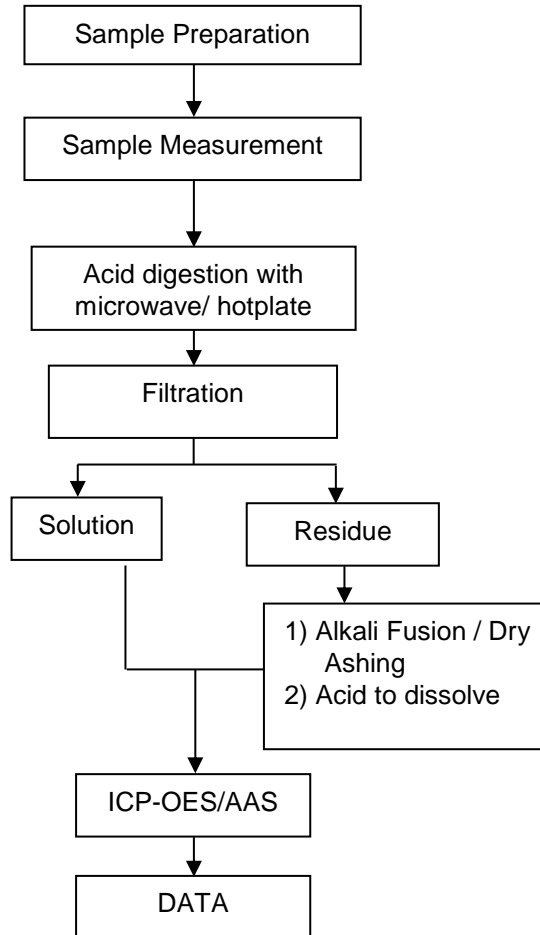

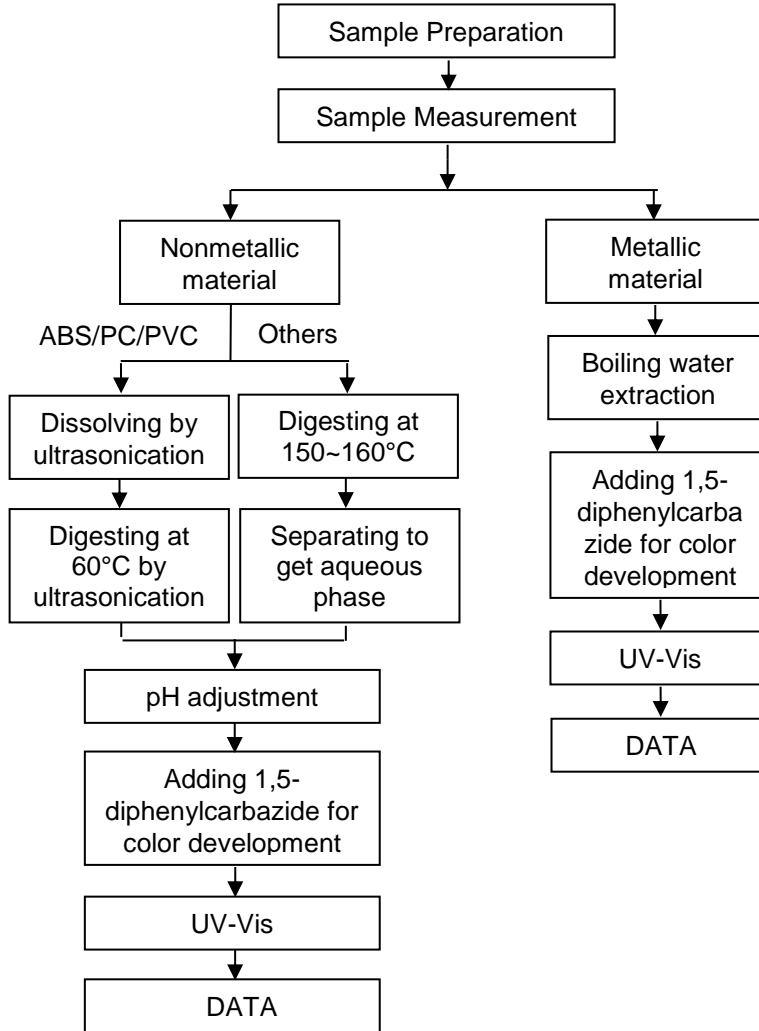

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

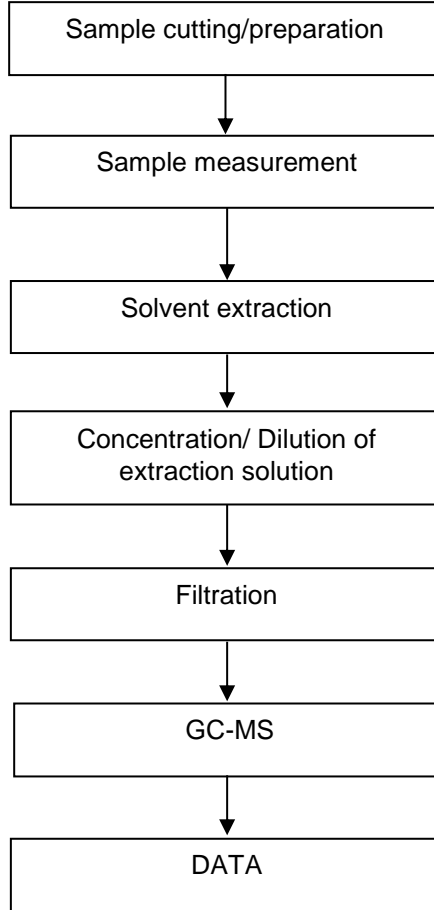

**PBBs/PBDEs Testing Flow Chart**



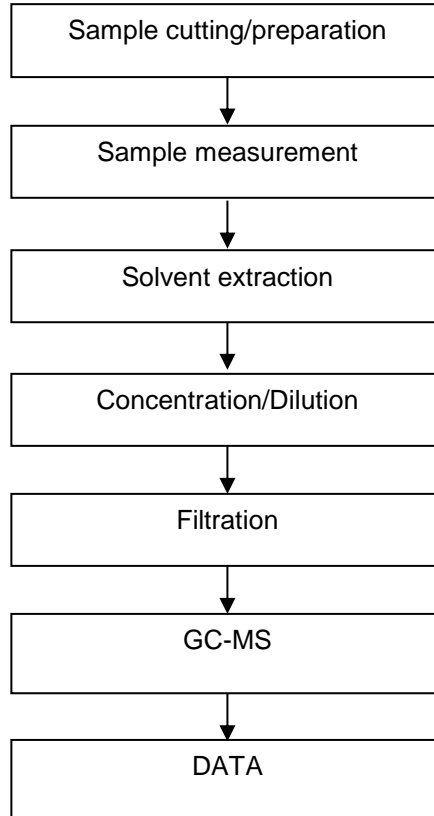

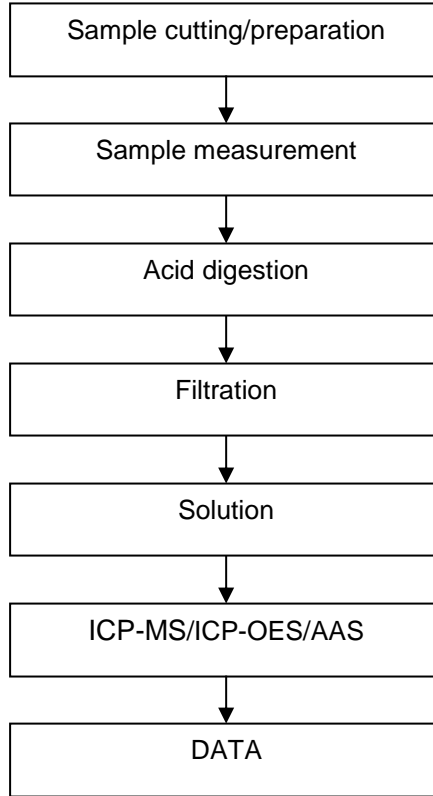

### Elements Testing Flow Chart



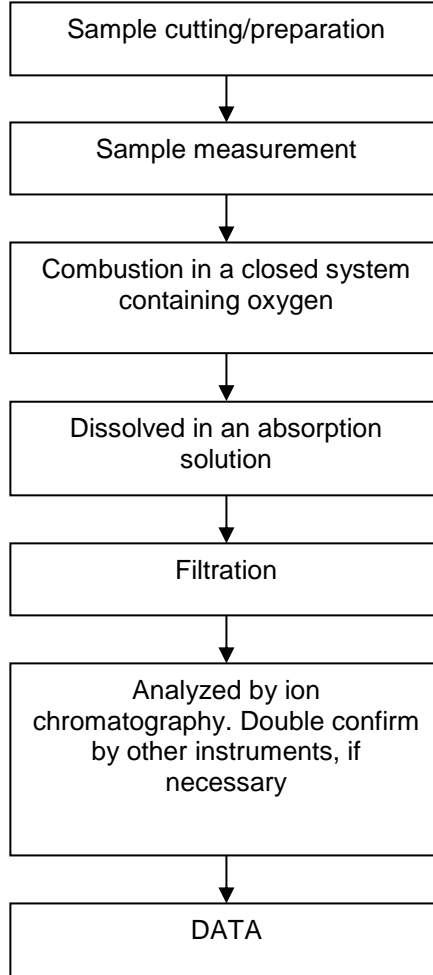

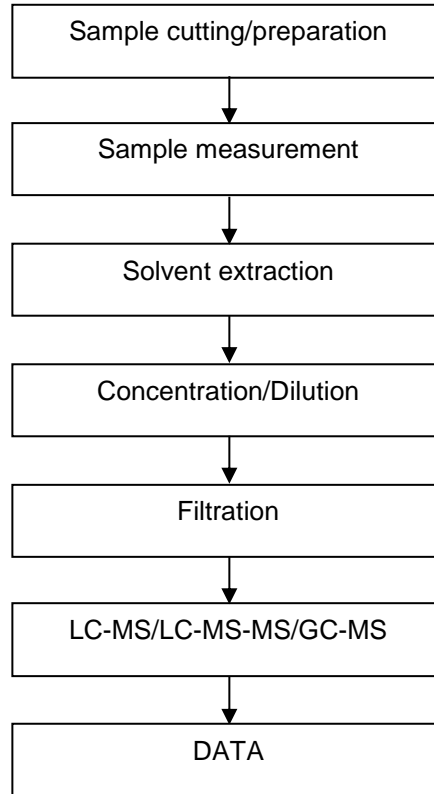

### PFASs/ PFOS/PFOA Testing Flow Chart



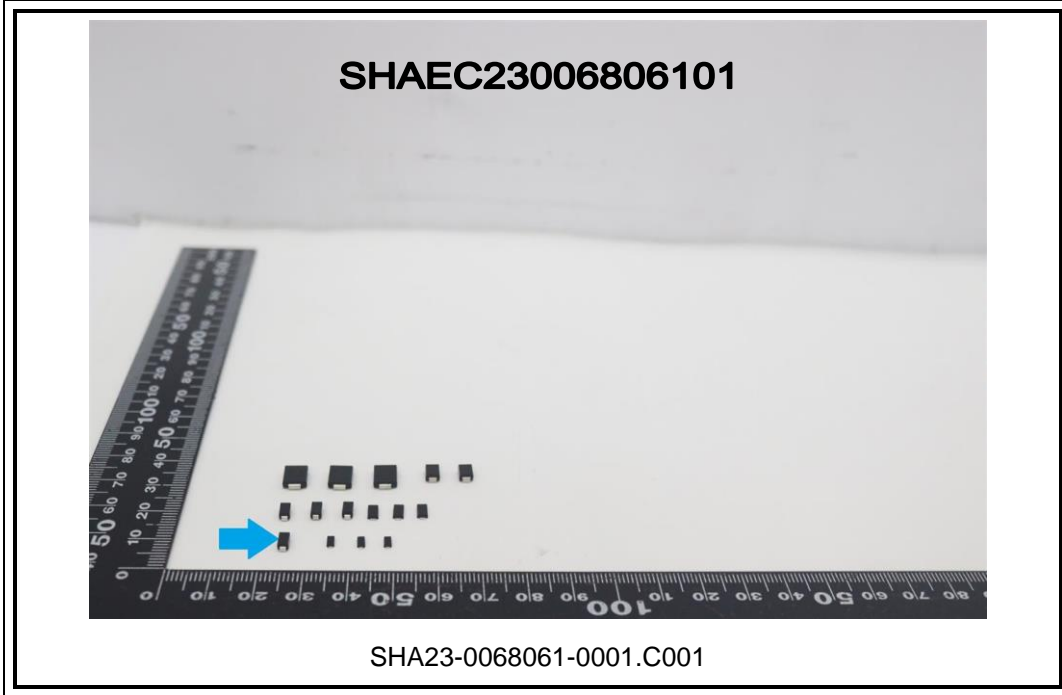
